68/16 **Public Speaking**

1 Cllr Jane Smith reported Muff Wiltshire's concerns about having to reverse around blind bends on Barnsley Lane due the limited number of passing places. Can the council request DCC acknowledge this and Beighton Hill as single track lanes and provide suitable passing places to reduce the hazards? Cllr Smith also reported a resident's concerns that the defibrillators are not currently readily accessible.

2 PCSO Paula Bennett had forwarded details of the latest Police Speed Watch scheme and the council will ask for the police to carry out the initial survey of existing data to establish whether the police consider a community speed watch scheme is appropriate.
