- 1 **AVA/2019/0147 – Holly Cottage, Gorses, Ireton Wood** – proposed modernisation and extension of semi-detached cottage – **APPROVED** 10 May
- 2 **AVA/2019/0237 – Rakestones Farm, Gorses, Kirk Ireton** – Listed Building consent for alteration to internal loft hatch and boarding out the loft – **PERMITTED** 3 May.

- 3 **AVA/2019/0427 – Storage Unit, Cliffash Lane, Idridgehay** Demolition of an existing portal frame building and the construction of a replacement barn style dwelling (This represents a Departure from the Adopted Development Plan and may affect the setting of a Listed Building) – Reg 31 May – Decision due under DP 26 July – PC object as contrary to VIA L1 and H1 being oversized new build in the open countryside within SLA and adjacent to the Idridgehay Conservation Area
- 4 **AVA/2019/0501 – Coneygrave Farm, Alderwasley** – Variation of condition 4 of AVA/2017/0741 to use powder coated aluminium windows instead of timber – Reg 28 May – decision due under DP23 July - PC no comment
- 5 **AVA/2019/0533 – Storer Farm, Ashleyhay** – retrospective Listed Building consent for replacement two replacement windows and creation of an en suite – Reg 10 June– decision due under DP 5 August – PC no comment

- 6 Enforcement action (ENF/2019/0004) going ahead at **Rakestones Cottage, Gorses, Kirk Ireton** following refusal of retrospective application AVA/2018/0005 for the removal of the storage building, track and hardstanding and the land reseeded by 8 October 2019.
