59/19 Public Speaking

- Cllr Smith asked the council on behalf of Muff and John Wiltshire to continue to press AVBC to seek immediate compliance with the full landscaping conditions at the pig farm if not, residents will take the matter to the ombudsman. She also passed on Jeremy Bate's comment that between the parish council's letter of complaint and AVBC's response, nothing had actually changed on site.

 Cllr Tatler wished to pay tribute to Philip Hurt who died before Christmas, saying that he served the community both as Chair of the Parish Council from 1984 to 1991, and again as councillor from 2007 to 2011, with dedication and outstanding commitment and would be greatly missed.

- 9 Enforcement action to remove the platform of hard standing and implement the agreed landscaping scheme at Land at Fir Wood Farm, Wirksworth Road, Idridgehay. The council discussed the response from Julian Townsend at AVBC to its letter sent after the November meeting and AGREED to write to urge full compliance with the enforcement of both the landscaping and removal of the platform as well as to ask for details of what has been agreed with the landowner, the time constraints given, if these had been approved by a landscape expert and to request a

- meeting of all parties including the parish council and a landscape expert to help conclude this matter asap.
- 10 Storage Unit, Cliffash Lane the appeal against refusal of PDR/2019/0005 was dismissed on 6 December
- PDR/2020/0002 Storage Unit, Cliffash Lane Application for prior approval for conversion of a detached portal framed building to form a single dwelling. Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) Schedule 2, Part 3, Class Q Valid 3 January 2020 decision due under DP 31 January after discussion, it was AGREED to object to this application as to previous applications on this site, as inappropriate in the setting of the open countryside of the SLA and adjacent to the Idridgehay Conservation Area, contrary to IAA PC's NDP H2; and as a conversion under GPDO to replace like for like, the proposed plan showing additional windows and entrance would not be appropriate.

62/19 Financial Matters

- It was **AGREED** to **APPROVE** the Statement of Accounts as at 8 January 2020 and the Chair duly signed this and the bank statements showing the Current account at £511.98 and the Business Reserve account at £11,774.08. The Chair and Vice chair also signed a Transfer of Funds authorisation for £1,500 to cover future known payments.
