MINUTES OF THE MEETING of IDRIDGEHAY, ALTON AND ASHLEYHAY PARISH COUNCIL held in the Village Corn Store, Wirksworth Road, Idridgehay on WEDNESDAY, 10 JULY 2019

Present: Cllrs R Tatler (Chair), C Hempshall, D Ibbett, J Matthews, J Smith and M Westbrooke, and R Hallam (Clerk).

There were no members of the public present.

- 17/19 Apologies for absence Cllr E Matkin
- 18/19 Variation of Order of Business it was agreed to defer item 16/19 until Cllr lbbett's arrival
- 19/19 Declaration of Members' Disclosable Pecuniary Interests none

20/19 Public Speaking

- Cllr Smith commented on a curt letter from AVBC regarding the non-return of a nil expenses form for the uncontested election in May. Cllr Westbrooke said he had found the threat to involve the police as unsettling. The councillors asked the clerk to write to AVBC expressing disappointment that no reminder letter had been sent as after previous elections and their concern over the inappropriate and heavy handed approach on an administrative matter.
- There was no report from either Cllr Taylor or the PCSO.
- No members wished to declare a Disclosable Pecuniary Interest or give evidence under the Code of Conduct relating to the Agenda items.
- 21/19 The Minutes of the Annual Parish and Annual Parish Council Meetings held on 8 May 2019 as previously circulated and published were APPROVED as a correct record of the meeting and signed by the Chair.

22/19 Planning Matters:

The following decisions were **NOTED**:

- 1 AVA/2019/0147 Holly Cottage, Gorses, Ireton Wood proposed modernisation and extension of semidetached cottage – APPROVED 10 May
- AVA/2019/0237 Rakestones Farm, Gorses, Kirk Ireton Listed Building consent for alteration to internal loft hatch and boarding out the loft – PERMITTED 3 May.

The following applications still awaiting decision were **NOTED**:

- AVA/2019/0427 Storage Unit, Cliffash Lane, Idridgehay Demolition of an existing portal frame building and the construction of a replacement barn style dwelling (This represents a Departure from the Adopted Development Plan and may affect the setting of a Listed Building) Valid 31 May Decision due under DP 26 July PC object as contrary to VIA L1 and H1 being oversized new build in the open countryside within SLA and adjacent to the Idridgehay Conservation Area
- 4 AVA/2019/0501 Coneygrave Farm, Alderwasley Variation of condition 4 of AVA/2017/0741 to use powder coated aluminium windows instead of timber Valid 28 May Decision due under DP 23 July PC no comment
- 5 AVA/2019/0533 Storer Farm, Ashleyhay retrospective Listed Building consent for two replacement windows and creation of an en suite Valid 10 June decision due under DP 5 August PC no comment To consider the following and any further planning matters:
- Enforcement action (ENF/2019/0004) at **Rakestones Cottage**, **Gorses**, **Kirk Ireton** in abeyance as an appeal lodged against the refusal of retrospective application AVA/2018/0005 for a storage building, track and hardstanding.
- AVBC Legal team now deciding how to proceed with enforcement action to remove the platform of hard standing and implement the agreed landscaping scheme at Land at Fir Wood Farm, Wirksworth Road, Idridgehay after the refusal of recent applications AVA/2018/1061 and 1062.
- AVA/2019/0680 Ithersay cottage, Ecclesbourne, Lane, Idridgehay proposed demolition of garage and rebuild plus extension to house Valid 3 July Decision due under DP 28 August Sited within the Idridgehay Conservation Area and SLA After discussion, the council commented it was once again disappointing that there is no reference to the Neighbourhood Plan (despite this being part of the planning process since 2015) or any reasoning given which could enable the council to support the application. It was AGREED that there was no objection to the extension to the existing house, but the demolition of the garage and proposed new larger 3 storey

dwelling on a different footprint, was cause for concern and should be the subject of a separate planning application. The proposed plans show that the footprint and scale of the proposed new build are larger than the existing garage and sited closer to the existing house. As a result it would be more prominent in the landscape. It was therefore **AGREED** to object to the proposed new development as contrary to AVBC's EN6 EN7 and EN27 and IAA PC NDP Landscape 1 (f).

23/19 Financial Matters

- 1 It was **AGREED** to **APPROVE** the Statement of Accounts as at 10 July 2019 and the Chair duly signed this and the bank statements showing the Current account at £965.54 and the Business Reserve account at £10,714.64.
