- 1. During the 15- minute period made available for members of the public and members of the Council to comment on any matter, to ask questions or submit comments about parish matters, the following was raised:
- 1.1 That the organisers of the car rally that is said to be held on the 15th April, have taken note of requests to avoid the Beighton Hill/Barnsley Road area and to keep noise and interference to a minimum.
- 1.2 That the Camping Club had accepted the site at Beighton Hill(planning application 48/11 1/1below) but limited the number to ten tents. This would still require permitted access and wastedisposal facilities which may not receive planning approval in view of present enforcement orders.
- 1.3 Though it was difficult to assess how much the web site was being accessed it was thought it may not be as high as was hoped. Future newsletters would further advertise it and encourage involvement..

Request being made for case to be referred to Planning Board for decision. Refused, but to note recent correspondence for authorised camping which had been accepted by the Camping Club but limited to ten tents.
- 1.2 AVA/2011/0927 Portal frame agricultural building for use as grain store on land off B5023. PC strongly objected for reasons given in previous application which was refused on appeal. Present numbered application refused but further appeal lodged, the result of which is anticipated early in April.
- 1.3. A VA/2011/1180 Alteration and extension to house Uppercroft, 3 Beighton Hill. PC nil objections. Permitted
