MINUTES OF THE ANNUAL MEETING of IDRIDGEHAY, ALTON AND ASHLEYHAY PARISH COUNCIL held in St James' Church, Wirksworth Road, Idridgehay on WEDNESDAY, 11 MAY 2016 starting at 7pm.

Present: Cllrs R Tatler (Chair) D Ibbett, J Matthews, J Smith, M Westbrooke, F White and R Hallam (Clerk).

In attendance: CIIr D Taylor (AVBC and DCC elected representative) and one member of the public.

- 1/16 Election of Chair for the Council Year 2016/17
 - It was proposed and seconded that Cllr Robert Tatler be nominated Chair for the year 2016/17. There were no other nominations and therefore it was so **RESOLVED**.
- 2/16 Chair's Declaration of Acceptance of Office
 Cllr Tatler accepted and duly re affirmed the previously signed Declaration of Acceptance.
- 3/16 Election of Vice Chair for the Council Year 2016/17
 It was proposed and seconded that Cllr Jane Smith be nominated Vice Chair for the year 2016/17. There were no other nominations and therefore it was so **RESOLVED**.
- 4/16 Vice Chair's Declaration of Acceptance of Office Cllr Smith accepted and duly re affirmed the previously signed Declaration of Acceptance.
- 5/16 Completion of Councillors' Acceptance of Office and Register of Members' Interests

All Councillors present re affirmed their previously signed Declaration of Acceptance and stated there were no changes to their previously tendered Register of Members' Interests

- 6/16 Apologies for absence received from Cllr Eric Matkin.
- 7/16 Variation of Order of Business none
- **Declaration of Members' Disclosable Pecuniary Interests** Cllr Mike Westbrooke recorded a personal interest in AVA/2016/0469 and 0470 being his neighbour's adjoining property.

9/16 Public Speaking

- Mick Smith stated that he would be writing to complain about the Planning Board meeting of 18 April and asked the council to do likewise. He also said he was available to do the Minor Maintenance Work if no one else was interested. Cllr Jane Smith gave apologies from Muff and John Wiltshire and made the following comments on their behalf: They would be writing to complain about the Planning Board meeting in respect of the Neighbourhood Plan; the formation of the Community Forum which could advise the council is overdue; could DCC employ a lengthsman to clear ditches, gullies and drains.
- Cllr Taylor as DCC elected representative reported that discussions continued about the devolution and formation of unitary councils in the county. He had been asked to distribute prizes at the Blackbrook Residents Association event to celebrate the Queen's 90th Birthday. As AVBC elected representative Cllr Taylor reported that the Council Leader (and Planning Board Chair) Alan Cox was one of two conservative members to lose their seats in the local elections. He told the council he was disgusted at the Planning Board's decision to approve the latest applications at the pig farm. He was shocked by members' ignorance of the VIA NDP policies and apologised on their behalf. Following the elections, the membership of the Planning Board will change. He has called in AVA/2016/0467 a new application at the pig farm to be decided by the Planning Board if the officer recommends approval as contrary to AVBC Saved Policy EN6 and VIA NDP B1 and L1. He has also requested a site visit.
- 3 Cllr Westbrooke told the council he had no objection to AVA/2016/0469 and AVA/2016/0470 which join his neighbour's house to their shared barn.

- AVA/2015/0660 and 0661 Land Off Wirksworth Road, Idridgehay Erection of an agricultural storage building registered 29 July AVBC Planning Board APPROVED both applications on 18 April 2016. After discussion, it was AGREED to write to complain about the way the Planning Board had reached its decision and the lack of regard given to the VIA NDP's policies and legal status.
- AVA/2016/0074 White House Farm Barn, New Road, Ireton Wood proposed extension decision anticipated under Delegated Powers by 18 March PC made no objection or comment application WITHDRAWN
- 3 **AVA/2016/0103 Smithy Cottage, Ecclesbourne Lane, Idridgehay** proposed new 2 bed detached single storey dwelling registered 24 February PC objected application **WITHDRAWN**
- 4 AVA/2016/0244 White House Barn, New Road, Ireton Wood listed Building Consent application supports the planning application to construct a ground floor extension to White House Farm Barn already submitted (reference AVA/2016/0074) registered 8 March application WITHDRAWN
- AVA/2016/0245 White House Barn, New Road, Ireton Wood proposed Conversion of existing redundant farm building to residential dwelling registered 9 March APPROVED 19 April
- 6 AVA/2016/0289 Clear Springs Farm, Sandhall Lane, Alderwasley proposed new vehicular access and track to service Clear Springs Farm only registered 22 March APPROVED 28 April
- 7 TRE/2016/0054 Old Forge Cottage Cliff Ash Lane, Idridgehay proposed removal of 3 Ash and 1 Plum trees registered 23 March APPROVED 29 April

The following applications were considered:

- 8 AVA/2015/1196 Home Farm House, Idridgehay proposed bungalow registered 21 December decision expected under Delegated Powers on 12 February PC objected as contrary to AVBC's Saved Policies H5 and EN1 and VIA NDP Policies L1 and H agreed time extension new determination date of 30 April
- 9 **AVA/2016/0257 Land Off Taylors Lane, Ashleyhay -** proposed erection of two 7m x 20m poly tunnels for horticultural use and construction of a timber/wire mesh chicken house, without foundation, approx size 4 x 4 metres registered 22 March **APPROVED** 10 May
- 9a AVA/2016/0467 Land off Wirksworth Road, Idridgehay Proposed extension to existing grain store registered 5 May decision expected under Delegated Powers by 29 June After discussion, it was AGREED to OBJECT to the continuing incremental development on this site contrary to VIA NDP B1 adding to the adverse visual impact on the landscape contrary to both AVBC's Saved Policy EN6 and VIA NDP's L1 and to comment that the proposed building is not an extension but an attached new building and the need for details of proposed landscaping.
- 9b AVA/2016/0469 & AVA/2016/0470 Ferrers Barn, Rood Lane, Idridgehay proposed enclosed link and alterations registered 29 April decision expected under Delegated Powers by 24 June PC no comment or objection.

The following enforcement matters were NOTED:

- 10 **ENF/2014/0120 Land on Wirksworth Road, Idridgehay –** site entrance now complete, a landscaping scheme submitted and planting to be completed within the current planting season (ie before 31/3/2016) it was **AGREED** to ask AVBC for evidence that the planting scheme had been correctly implemented.
- 11 ENF/2014/0291 and 0358 Black Swan Inn, Wirksworth Road, Idridgehay remains under investigation
- The Planning Appeal APP/M1005/Y/15/3141104 White House Farm, New Road, Ireton Wood against the refusal of proposed renovation and extension to White House Farm a decision is still awaited
