### 1/21 Election of Chair for the Council Year 2021/22

It was proposed and seconded that Cllr Robert Tatler be nominated Chair for the year 2021/22. There were no other nominations and therefore it was so **RESOLVED**.

- 9/21 Public Speaking
- Emily Chard updated the council with the latest traffic survey results with the two latest surveys revealing that the B5023 through the village had significantly more traffic per hour than the A517 through Hazelwood. She said the next step was to obtain a data recorder to present evidence to press DCC to allow VAS signs. She will ask the Community Speed Watch county leader if the police or CREST would provide this otherwise one can be purchased for around £250. Cllr Smith asked the council to support the DALC request to the government to reconsider its decision to end remote meetings as from 7 May larger councils will find it harder than ours to meet social distancing requirements.

- School; and disabled toilet facilities already exist in this green field site accessed by a narrow lane and without parking. The adverse impact created on this rural setting and landscape in SLA is contrary to IAA PC NDP Landscape Policy L1.
- 8 AVA/2021/0110 and 0111 Walnut Cottage, Barnsley Lane, Ashleyhay proposed porch extension, new and replacement windows, and doors Reg 3 February Decision due under DP by 29 March PC no comment or objection
- AVA/2021/0280 and 0281 Black Swan Inn, Main Road, Idridgehay proposed construction of single storey extension to form Snug Bar Reg 16 March Decision due under DP 7 May PC no comment or objection
- AVA/2021/0325 Daies Garden, The Green, Idridgehay proposed construction of 2 storey extension Reg 25 March Decision due under DP 21 May PC no comment or objection

- AVA/2021/0446 2 Millbank Cottages, Wirksworth Road, Idridgehay propose demolition of single storey extension and replacement 2 storey side extension Reg 26 April Decision due under DP by 18 June PC no comment or objection.

The following Decisions by the Planning Inspectorate were NOTED:

**Sherbourne Mill, Hillcliff Lane, Turnditch** - Appeal against refusal of AVA/2020/0306 for proposed construction of new access track - **DISMISSED**12 April 2021 – PC to press AVBC for enforcement action to remove the track and reinstate the hedgerow removed to make the unauthorised access.

**Ecclesbourne View, Rood Lane, Idridgehay** - Appeal against refusal of AVA/2020/0086 for proposed dwelling — **DISMISSED** 12 April 2021

Cllr Smith was pleased to report that both appeals referred to the IAA PC NDP's policies to support their decisions.

Cllr Smith also reported further unauthorised activity at **the Land at Fir Wood Farm**, **Wirksworth Road**, **Idridgehay** a new track being constructed from Barnsley Lane towards the unauthorised platform that should be removed under enforcement action.

#### 12/21 Financial Matters

- 14/21 Parishes' footpaths, pavements, hedges, and highways issues It was **NOTED** that residents had contacted both Cllr Taylor and Sarah Dines MP regarding the ongoing problem with the drain cover outside the Village Stores. Cllr Matkin reported that the road sweeper had cleared the pavement from South Sitch to Rood Lane.
- 15/21 The council discussed the '20's Plenty' Campaign and Cllr Matthews agreed to research the costs involved and report back to the next council meeting.
