102/19 Public Speaking

1 Cllr Matthews reported that the Community Speed Watch team can now restart its surveys following stricter rules following the COVID 19 epidemic. These include social distancing measures and leaving a 72 hour gap before using equipment shared with the Hazelwood team.

Cllr Matthews also reported that St James' Church had been cleaned but a risk assessment is required before it can reopen. The plan is to open one day a week for private prayer around the end of July. Wirksworth Team Ministry holds Sunday and daily services by Zoom but, with only 3 vicars to cover 10 churches, they are now considering the best way to reintroduce actual services.

- 1 It was **AGREED** to **APPROVE** the Statement of Account ending 8 July, and the Chair duly signed this showing the Current account at £1,806.73 and the Business Reserve account at £10,978.82.
- 2 There were no accounts to approve for payment.
- 3 It was **AGREED** to **APPROVE** a 2% increase in the Clerk's pay for 2020/21 as recommended by DALC as well as the increase in the office allowance to from £200 £300 pa in line with nationally agreed rates.
- 106/19 It was **NOTED** that although the lock down for COVID 19 is gradually being eased, the Idridgehay Community Support Group continues but unfortunately Idridgehay Village Shop remains temporarily closed. The Black Swan has reopened and continues to offer a takeaway service. The Idridgehay Defibrillator Fund is purchasing equipment to comply with measures following the epidemic.
- 107/19 **Parish Maintenance Matters**: DCC has been given a list of the footpaths for clearance. AVBC have not yet agreed to pursue an insurance claim in respect of the former bus shelter at the end of Windley Lane
- 108/19 It was **AGREED** to postpone the next publication of the newsletter until the September meeting but to keep the website as up-to-date as possible.
