- **30/17** Apologies for absence received from ClIrs Tatler and Ibbett and AVBC and DCC representative ClIr David Taylor. As ClIr Tatler was absent, ClIr Jane Smith as Vice took the chair and welcomed everyone to the meeting.

- 1 No member of the public or council wished to comment on any parish matters.
- 2 PCSO Paula Bennett reported that her area had increased to include Heage and Ambergate. The monthly mobile police surgery would again come to Idridgehay dates will be provided shortly for the council's notice boards and website. After refresher training in mid October, she would carry out the 3 surveys needed and train volunteers for the Community Speed Watch Scheme which could be run up to 4 days a month with equipment provided by the police. Volunteers for the scheme will be sought in council's next newsletter. The Clerk and PCSO Bennett will check insurance cover needed for both the volunteers and the equipment used. - 37/17 It was **AGREED** to defer the review of the council's risk assessment until the next meeting in November to allow the Clerk time to prepare a business continuity plan
- 39/17 It was AGREED again to report the pot holes on Beighton Lane and the missing signage on Prathall Lane, Ashleyhay and to liaise with Cllr Taylor and the various authorities involved to sort out the noisy raised manhole cover outside the village store. Cllr Westbrooke said he would again report the 'Long Delays' sign left on the triangle at the start of Rood Lane. It was AGREED to participate in the DCC Minor Maintenance Repairs Scheme to clear the parishes' footpaths and to continue in the DCC Snow Warden Scheme Hazel and Michael Haslam being happy to continue as wardens for Idridgehay and Cllr Smith being willing to liaise for Ashleyhay. It was AGREED to ask AVBC to carry out the necessary repairs on their bus shelters as soon as possible and to investigate the DCC 50/50 bus shelter replacement scheme.
