### **COUNCIL NEWS**

The council continues to meet on the second Wednesday of every other month. Agendas and minutes are published on the website, as well as being posted on notice boards.

The council has contested the planning applications for the grain store on land off the Wirksworth Road and the conversion of a cattle shelter on Rood Lane. Both were taken to the full Planning Board which ruled in favour of the applicants. A further application for the development of a caravan site in the Beighton Hill area has been similarly contested robustly and a decision is awaited. (This has now been rejected. Ed.)

The snow warden scheme and purchase of extra grit will be continued this year. Many residents took advantage of it last year and were grateful for the opportunity to do so. There is also a reminder of the beneficial schemes being promoted for reducing energy bills through collaborative buying. It is a question of speaking to your neighbours and getting information on line.

### NEIGHBOURHOOD PLAN UPDATE

The council continues to be wholly committed to preserving the rural landscape and in particular the Ecclesbourne Valley. To this end it will be taking an active part in the consultation process of AVBC's Core Strategy starting in March next year while at the same time, considering drafting a Neighbourhood Plan – how a community sees its situation in years to come. There will be further information and consultation with local residents in due course.

Meanwhile, the Neighbourhood Plan has to be council lead with most of the work being carried out by a group of local volunteers. Anyone interested in finding out more or offering to help, please contact the Parish Council, or come along to the next meeting on November 14<sup>th</sup> at The Corn Store. In order to allow extra time for discussion this meeting will start at the earlier time of 6.30pm.
