PLANNING APPLICATIONS


Some of you are aware that there has been more than one contentious agricultural planning application in the Parish in the last 12 months. Two related to land at the heart of the Parish. Both would have been passed by the Planning Officers but due to community involvement our Elected Members were given the opportunity to vote on the proposals. They voted against. Both went to appeal by the Planning Inspectorate and were rejected primarily on the basis of their impact on the Special Landscape Area (SLA).

The map opposite shows the extent of the SLA. We are very lucky to have this protection and the PC is determined that, with your support, this designation should remain. You only have to



travel along the Ecclesbourne Railway to appreciate how fine and un-spoilt the landscape is.

SPECIAL LANDSCAPE AREA UNDER THREAT



The changes in local and national planning policy threaten the future existence of the Special Landscape Area which forms most of the Parish.
