IAAP - 40/23To receive updates about progress on resolutions:

a) SIDS (Speed Indicator Devices)

The Clerk informed the Council that the Office of Police and Crime Commissioner (OPCC) had made full payment of the £3,000.00 grant the authority was successful in applying for to fund the purchase of SIDS within the Parish.



Cllr Tatler informed Council that the contracted supplier has not yet confirmed a date for delivery. The Clerk confirmed to Council that no demand for payment had yet been received.

b) Public Footpath Maps (Railway Station)

Cllr Tatler presented the Council with a draft design to replace the existing map that needs repair. The new design will also mark the coronation of King Charles III.

It was proposed by Cllr Westbrooke, seconded by Cllr Tatler, and approved unanimously that the Clerk purchase a replacement sign using the funds made available by the Derbyshire County Council Coronation grant.

c) Standing Orders (Amendment)

The Clerk informed the Council of the need for the Parish Council to formally amend its standing orders to allow the Chairman of the Council to

"The Chairman of the Council in conjunction with the duly appointed Clerk may, as the need arises, postpone or cancel meetings of the authority following written consultation with all councillors of the authority."

This amendment was proposed by Cllr Smith and seconded by Cllr Westbrooke and agreed upon unanimously.

d) Cliffash Lane - Safety Mirror

Cllr Westbrooke suggested there was a need for a road traffic safety mirror on Wirksworth Road near the crossing point used for St James' Church. It was proposed by Cllr Tatler and seconded by Cllr Smith and agreed unanimously, that the Clerk should contact DCC to ascertain if the County Council would support the Council in attaining the relevant permission from the Department for Transport (DfT)
