IAAP – 49/23 Reports from Borough & County Councillors and Derbyshire Police

A report was given by Cllr David Taylor on his work at both Amber Valley Borough Council and Derbyshire County Council and his focus on recent flooding that has impacted the county.

Cllr Taylor informed the Council that Cllr Orton is looking to attend a future meeting of the Council as the newly elected co ward councillor on Amber Valley.

IAAP – 51/23 To receive updates about progress on resolutions:**a) SIDS (Speed Indicator Devices)**

Cllr Tatler informed the Council that the SIDS from SWARCO have now been installed in the Parish. One of the conditions imposed on the Council by both Derbyshire County Council (license condition) and the Office of Police and Crime Commissioner (grant condition) is that the Council is required to provide both authorities on request data obtained by the SIDS within the Parish.

Cllr Westbrooke advised that one of the SIDS was not working and would provide the Clerk with the details to raise with SWARCO as well as provide geographical data for the SIDS to be added to the Council's insurance policy.

b) Public Footpath Maps (Railway Station)

Cllr Tatler informed the Council that the newly purchased sign has now been installed at Ecclesbourne Railway Station, replacing the prior sign with a new metal sign purchased with the grant money from Derbyshire County Council to celebrate His Majesty King Charles III's coronation.

The Clerk was asked to ascertain if the Council had a supply of waypoint disks or if new disks needed purchasing.

c) Cliffash Lane – Safety Mirror

The Clerk informed the Council that DCC required the exact location at which any road mirror would be placed. Cllr Westbrooke agreed following the discussion that he would raise the matter with the PCC to see if they would fund the project.
