IAAP – 58/23 To approve the minutes of the Parish Council Meeting held on 8th November 2023

The minutes were proposed by Cllr Westbrooke, seconded by Cllr Hempshall and agreed upon unanimously.

IAAP – 60/23 Reports from Borough & County Councillors and Derbyshire Police

There were no reports given from Borough and County Councillors as well as from Derbyshire Police.

IAAP – 61/23 To consider any planning matters:

AVA-2023-0957 - Valley Farm Old Hillcliff Lane Turnditch Belper Derbyshire DE56 2EA Erection of a replacement dwelling and demolition of riding arena.

It was proposed by Cllr Smith and seconded by Cllr Tatler that the Council oppose the application on the grounds that it does not comply with the established Neighbourhood Plan policies; Landscape L1 and Housing H1 and the enacted policies of AVBC regarding application within a Special Landscape Area. This was agreed unanimously.

AVA-2023-0920 - Alton Manor Farm Unnamed Road Comprising Section Of B5023 From Idridgehay To Ashleyhay Idridgehay Belper Derbyshire DE56 2SH Non material amendment to PDR/2021/0064 for windows doors in different position than shown on submitted elevation drawings

AVA-2023-0882 - Dirty Lane End Cottage Storer Lane Ashleyhay Matlock Derbyshire DE4 4AH Replacement of derelict agricultural building with new agricultural building for livestock shelter and forage storage above (this may affect the setting of a listed building)

AVA-2023-0591 – Cliffash Farm Cliffash Lane Idridgehay Belper Derbyshire DE56 2SE To build a tractor shed (may affect the setting of a listed building and character of the conservation area)

It was proposed by Cllr Smith and seconded by Cllr Tatler that the Council oppose the application on the grounds that it does not comply with the established Neighbourhood Plan policies; Landscape policy L1, and contrary to the Local Plan Environment policies EN6, EN1 and EN11. This was agreed unanimously.

IAAP - 62/23To receive updates about progress on resolutions:

a) Cliffash Lane Road Safety Mirror

The Clerk informed the Council Derbyshire County Council would not approve a license for a road mirror. It was proposed by Cllr Westbrooke and seconded by Cllr Smith and agreed unanimously that the Council contact DCC to assess measures to make the road safer for pedestrian crossing.

b) Churchyard Closure Update

The Clerk informed the Council of the correspondence between the PCC and AVBC over the responsibility for the closed churchyard. It was proposed by Cllr Smith and seconded by Cllr Brooks and agreed unanimously that the Clerk write to Cllr Jane Orton and Cllr David Taylor of AVBC to ask if they could intervene and resolve the matter.

c) CiLCA

The Clerk informed the Council that he meets the requirements to begin his CiLCA qualification once a place opens on the course.

IAAP - 63/23Finances:

a) Statement of Accounts
